Reisterstown United Methodist Nursery School is a Christian school and that is the foundation of our existence. Our faith is expressed in a multitude of ways: Bible lessons for every child, prayers at meals and other times during the day, and Christian songs. We have a theme-based curriculum into which we incorporate the Word of God and various Bible stories. The children will also learn about farms, fire safety, volcanoes, bugs, nursery rhymes, and other subjects, as well as how to write their names and how to follow directions and get along with others. We go to chapel once a month with our Pastor and her husband to learn about Jesus and other important Bible figures. There will be a Christmas program in December to celebrate the birth of Jesus for which we practice starting after Thanksgiving. We also learn about Jesus at Easter as a part of our program as Easter is the foundation of our faith. We weave faith into our lessons and teach children that Jesus loves them no matter what. God is the Creator of the world, and He is always there for them. God made each of us, and we are all beautiful.

These activities are an inherent aspect of our program, and it would be impossible to avoid all exposure to religious education because of our philosophical base. We are happy to welcome families of all beliefs but recognize that our program is not the right fit for all families. If you feel our approach is not consistent with what you are seeking for your child, you may want to consider a program that better suits your needs. If you have just read this and we are the program for you, please fill out the application form on the reverse side and return it as soon as you can so we can reserve a spot for your child. We will contact you to set up a tour for you and your child to meet the staff and explore our classrooms.

If your child has any IEP, IFSP, or other educational or behavior plan that you are using in conjunction with professionals with whom you are currently working, we ask that you provide us with a copy of the plan upon registration or as soon as it is received so that we can arrange a conference to discuss how to best meet the needs of your child.

You must provide a copy of any custody agreements that affect the child's daily schedule and living arrangements.

Students who require a modified diet due to non-medical reasons will incur an additional monthly snack surcharge of \$25.

Three-year-olds who are not fully potty trained will incur a \$25 per month surcharge until fully potty trained (see Parent Handbook for definition of "fully potty trained").

I accept the requirements of registration and understand that the registration fee is non-refundable. I understand that I must notify the school by July 15, 2026 if my child will not be attending school, or I am liable for the first tuition payment due on August 1, 2026.
